

Arthur B. Borton

O11 Illustrious Potentate Kevin Rhodes appointed Arthur Bruce Borton to be the Outer Guard of Murat Divan, Murat Shrine of Indianapolis, IN. Art has been active at Murat, serving as an aide to five Potentates as well as being Murat's Membership Committee Chairman from 2006 – 2008.

Art was born June 12, 1954, in New Brunswick, NJ. In 1958, the family moved to Lyndhurst, OH, a suburb of Cleveland, and Art graduated from Charles F. Brush High School in 1972. He received a B.S. in electrical engineering from Purdue University in 1976.

Art started his professional career as a technical sales representative for Diamond Shamrock Corporation in July '76. In 1980, he took a position with Procter & Gamble Industrial

Chemicals Division, and remained with P&G until joining Imperial Chemical Industries (ICI) in 1993. Getting tired of the travel, Art left ICI in spring of 2002 and started working as a realtor with F.C. Tucker Company at its Castleton office. With Shrine activities taking more and more time, Art left F.C. Tucker in 2013.

Art's Masonic connections started in 1969 when he joined Selynma Chapter Order of DeMolay in Lyndhurst, OH. Art was very active in DeMolay where he served as Master Councilor and earned several honors including the Past Master Councilor – Meritorious Service Award, Chevalier, Scottish Rite Scholarship for Outstanding DeMolay for the Second District of Ohio, and Art was named the Outstanding DeMolay for the state of Ohio, the Distinguished Service Award, in 1972. He was also recognized with the Active DeMolay Legion of Honor in 2008.

Art joined Woodward Lodge #508 in Lyndhurst, OH, in March 1976. He received his first two degrees while at Purdue through courtesy work provided by Lafayette Lodge #123 in Lafayette, IN. Art then received his Master Mason degree from Woodward #508, which was the Lodge sponsoring Selynma DeMolay. He has since maintained dual membership with Calvin W. Prather Lodge #717 here in Indianapolis. In November 1980, Art joined the Ancient Accepted Scottish Rite Valley of Cincinnati, and later transferred to Scottish Rite Valley of Indianapolis. He was a charter member of DeMolay Mark Master Chapter #2 in Cleveland, OH, in 1981. He then completed his York Rite work joining Prather





York Rite Chapter in September 2007.

Art joined Murat Shrine in the December ceremonial in 1995. Business travel kept him away from Murat, but when he got off the road and into real estate, he got active in Shrine activities. In 2002, he joined the Movers and Sheikers (now the Murat Shrine Business Connection), serving as president in 2007. In the fall of 2003, he joined the Order of the Q, serving as their presiding officer in 2008. Spring of 2004, Art joined Mobil Nobles, becoming president in 2006 and secretary after that. He worked on the Murat Membership Committee from 2004 - 2008 and was chairman from 2006 - 2008. He also worked on the Murat Shrine Public Relations Committee from 2006 – 2008. As a past president, he joined Kowad 'al Sabakin in 2007. He has also been a Potentate's aide since 2006.

raternal organizations have been lifelong! Joe has long been associated with "the family" as he was indoctrinated as a youth. Joe's grandfather, Brooks, and both uncles were members of Parke Lodge 8 and Zorah Shrine in Terre Haute. Brooks Collings 33rd was also very active in the Ancient and Accepted Order of Scottish Rite. Joe's father, Dick, a member of Phi Gamma Delta (Wabash), continued walking the sands through the Indianapolis Valley Scottish Rite and Zorah Shrine. The tradition continued while attending Wabash as Joe led the Delta Tau Delta fraternity. Son Blair also "saw the light" and followed his grandfather's

footsteps as a member of Phi Gamma Delta (Wabash). As need presented itself, the role of brotherhood has always taken a front seat.

Family is a focus in Joe's life, both in upbringing and business. Growing up in Parke County, the family roots were involved in civic, community, and the family business, Ferguson Lumber. Joe's (now in its fifth generation) great-great grandfather, Solon Ferguson, founded the firm in 1868. Family worked within the business and Joe's grandfather, Brooks Collings, was introduced through marriage. The business has two locations today in Fountain and Hendricks counties.

Those civic and community ties led to board alignment in the local Chamber of Commerce, Rotary, School Board of Education, Indiana Lumber & Builders Supply Association, National Association of Wabash Men and Billie Creek Village, a turn-of-the-century theme village. Having presided over the Indiana Lumber Association years prior, Joe was asked to lead a new organization between Michigan and Indiana, the Midwest Building Suppliers Association, independent lumber dealers. Joe chaired the board of the National **Lumber Building Material Dealers Association in** Washington a few years prior. Joe currently serves as a commissioner of the Certified Association Executive Commission, the most paramount credential of the American Society of Association Executives, also in Washington, D.C.

One of the highlights of service was the selection to lead a Rotary International Group Study Exchange Team to the Middle East. Rotarian Joe, along with



four non-Rotarian professionals, studied the culture promoting understanding and peace while staying with Rotary host families in Egypt, Cyprus, Lebanon and Jordan. The team visited these Middle Eastern countries while the Gulf War ensued. His father Dick (a past District Governor) also led a GSE team in northeastern India and the family has continued support of a cataract program established in his name. Joe, a Paul Harris Fellow, has followed his father's interest in Rotary and has held several offices in the Central Indiana District, currently serving as an Assistant District Governor.

Joe began his journey in Parke Lodge 8 and was raised at the Calvin W. Prather Lodge 717 as a Freemason and is a member of the Ancient and Accepted Order of the Scottish Rite. He is also a member of Court 15 of the Royal Order of Jesters along with the Rockville Elks.

Joe is an elder in the Memorial Presbyterian Church in Rockville and resides in Avon with his wife Julia, son Sam (United States Marines), daughter Lexie (Avon High School cheerleader), and their two miniature dachshunds, CoCo and Ty. Anna Harrington and Sofia

GORDON J HUSK, FORMER CHAIRMAN, BOARD OF GOVERNORS, SHRINERS HOSPITAL®-CHICAGO

s reported in earlier articles, Anna Harrington walked 3,800 miles across the United States to raise awareness and money for Shriners Hospitals for Children as her thanks for the successful scoliosis treatment her nephew received in our Sacramento hospital. She is now walking to raise awareness of the plight of an estimated one billion people in this world who do not have access to safe drinking water.

Anna says, "A local newspaper in Portugal recently wrote an article about my walk when I was passing through. While my story got a bit lost in translation, they did print the names of my two favorite organizations: Shriners Hospitals for Children and Love Water."

This is a rough translation of the article:

Water Resources CARLA FRAGOSO

American Woman Travels the World to Raise Awareness

Seven years. Thousands of kilometers to tread. Many countries to know. A North American citizen is to travel around the world on foot, with a mission to raise awareness for the sacrifices that women and children are subjected to every day in such places as Africa, for a little drinking water.

Her name is Anna Harrington, she is 45 years old and is a native of Idaho, in the United States. During the next seven years, she is willing to make sacrifices for the common good, passing by Marinha Grande on the way to a greater cause. Alone, she started this walk in March, in Portugal. She made the decision after seeing news that in Africa, thousands of women and children go 35 kilometers or more for a few liters of drinking water. Thus, after her experience in 2014, where for 10 months she walked across America, covering more than six thousand kilometers to awaken public awareness of Shriners Hospitals for Children. In recent months, she slept in her tent in campsites or in public spaces, but also in private households or in more affordable housing when there was no alternative or time does not allow it. Armed with a small stove, she cooks some meals to save money, and takes only the essentials. Undaunted, no major fears aside from stray dogs that have crossed the road.









Her route includes countries like Spain, France, Germany, Czech Republic, Russia, China, but also Australia and South America. Outside of this challenge is only the African continent, whose problems originated this walk. Anna told JMG that she will not risk walking in Africa, given the existing dangers and greater difficulty in getting the necessary visas to enter different countries.

Anna has a son 22 years of age in the United States, and she said she will only return home next Christmas. Her work in a laboratory, connected to the field of medicine, will have to wait for the end of the walk, or alternatively, until the money runs out of her savings. To the JMG, Anna confided it has been a "love" experience, and she has received "very positive" feedback from people after explaining her cause, in various places where she has passed. Although she admits that it never crossed her mind to undertake a mission of this magnitude, the truth is that Anna has proved her worth as a citizen activist. After the mission in America, she

went to Nicaragua where she helped to install water filters, as a volunteer of Love Water, an international framework institution.

About the latest challenge, she created the blog www.annasworldwalk.com, which will tell some adventures that everyone can follow.

After sending the message above, Anna reported the following experience:

"When I passed through Marinha Grande, Portugal, in May, Miguel Tomazzini told me about a little girl at his son's school who was in need of a wheelchair. I asked Miguel if he could arrange for me to meet the parents so I could learn more about her situation. The next day, I met little Sofia, a beautiful 2-year-old girl with brown ringlets and a shy smile. Her medical condition requires a special stroller to support her upper body, and unfortunately, a traditional stroller was not an option and her parents were having difficulty finding one to meet her specific needs.

"Later that evening, I called my friend, Gordon J Husk, to ask if there was anything Shriners Hospital could do to help this little girl. Gordon contacted Dr. Jeffrey Ackman at Shriners Hospital for Children-Chicago, who enlisted the help of Tim Caruso, who is a therapist at the hospital and is also CEO of TKEN (The Kids Equipment Network). TKEN donated the adaptive stroller and the Indianapolis Horse Patrol generously paid for the expensive shipping. I recently presented the stroller to the family and they were overwhelmed with joy and gratitude. The Shriners helped a family that was thousands of miles away on the other side of the Atlantic. Thank you, Shriners, for all the awesome work you do all around the world."

Anna Harrington made many friends across America by completing her amazing walk while visiting nine Shriners Hospitals along the way. As she presented Sofia's stroller, she had the opportunity to make even more people aware of how Shriners help children. We applaud Anna for her outstanding determination and dedication to causes in which she believes.

Sbriners Hospitals for Children® is a pediatric bealthcare system of 22 hospitals dedicated to improving the lives of children by providing specialty care, innovative research and outstanding teaching programs. IANUARY 2017 17

AN EXCERPT FROM GENERAL ORDER NO. 1: FUNDRAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws: §335.3 USE OF NAME "SHRINERS HOSPITALS FOR

CHILDREN." The use of the name "Shriners Hospitals for Children" or reference to the IIospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the Board of Trustees of the Hospitals is prohibited.

§503.11 COMMERCIAL USE OF NAME

The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained

Now, therefore, IT IS HEREBY ORDERED:

- 1. Fundraising for Fraternal Purposes:
 - (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any fundraising activity without the express written consent of the potentate of the temple having jurisdiction thereof.
 - (b) There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
 - (c) The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.11 of the fraternal and charitable bylaws and that there is no representation, expressed or implied, that would lead a reasonably prudent person to believe that the proceeds will be for the benefit of Shriners Hospitals for Children. If the potentate is in doubt, he must receive the opinion of the Imperial Potentate who, after consultation with the Director of Temple Accounting, shall make the final determination.
 - (d) The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required by the temple bylaws.
 - (e) A copy of the temple potentate's written consent shall be mailed to the Executive Vice President, Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Shriners International shall be promptly mailed to him.

2. Fundraising for Charitable Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairmen of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P.O. Box 31356, Tampa, FL 33631-3356. No charitable fundraising activity shall be held in the jurisdiction of another temple without the written permission of the Potentate of that temple.
 - (1) A joint charitable fundraising activity with another 501(c)(3) charity may be authorized provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the Chairmen of the Boards of Directors and Trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
 - (2) A charitable fundraising activity conducted by a temple located outside of the U.S.A may be authorized for other charities, provided that the chairmen of the board of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

- (b) 100% of net proceeds (as defined in the Charitable Fundraising-Approval Anc Reporting provisions of the current General Order) from charitable fundraisis must be given to Shriners Hospitals for Children except for such portion there as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of the current General Order. Provided, however, if the chairmen of the boards of directors and trustees determine for good cause shown, that the law of the lan requires that a portion of the net proceeds must be distributed locally, then the may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.
- (c) The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising— Approval And Reporting provision of the current General Order.
- (d) This section shall not apply to activities exempt under §335.4(b) of the bylaws of Shriners International.
- (e) Each independent corporation or entity that receives the permission of the chairmen of the boards of directors and trustees to raise moneys for Shriners Hospitals for Children, and which does not have its financial statements reviewed pursuant to §334.6 & §337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to Shriners International within 120 days of the activity.
- 3. Statement of Purpose and Disclosure:
 - (a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted materials, regarding the use of the proceeds. Examples:

"Proceeds are for the benefit of (Shriners)
Shrine Club) activities"	

"Proceeds are for the benefit of Shriners Hospitals for Children."

- (b) Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets, programs, documents and electronically transmitted material that "payments are not deductible as charitable contributions."
- (c) There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.
- 4. Compliance with Applicable Laws:

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

- 5. Financial Records:
 - (a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles and affiliated and appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.
 - (b) The temple must retain such detailed financial records for a period of seven (7) years.
 - (c) There must be compliance with Financial Reporting on Charitable Funds and Activities provision of the current general order.
- 6. Notification to Nobility:

A copy of the *Fundraising Activities* provisions of the current general order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

7. Discipline:

Any officer, Noble or temple which violates a provision of *Fundraising Activities* is subject to discipline pursuant to the bylaws of Shriners International.

New Patient Referral Process Approved at Imperial Session



Great news! It is now easier than ever to refer a patient to Shriners Hospitals for Children®! At the 138th Annual Session in July 2012, the attending delegates approved amendments to the Colorado Bylaws 509.2 and 509.3 which simplified the way for patients to access Shriners Hospitals. Patients/families no longer need to fill out a two-page application form that must be processed before being considered for treatment. While this is a big change for our system and YOU, we want to assure you that our Shriners are more important than ever in finding children that need our help; as well as informing the public about the noble mission of Shriners Hospitals for Children. We need your participation now, more than ever, to reach more patients. This new process makes it easier for our patients and will still allow for engagement with the nobility. Travel and transportation support should not change. Contact your Shrine temple or hospital if you have questions.

This new intake process continues to support your valuable referrals, without the added step of completing a patient application. Instead, simply provide patients/families with the Shriners Hospitals for Children patient referral card, which may be obtained from your hospital or Shrine temple. In addition, a new Patient Referral Form will be forthcoming in the near future. However, the referral card is preferred, with the patient/family calling the hospital's referral intake line directly. Why? This is the quickest and most convenient way for a patient to get the care they need.

When did this start? In October 2012, Shriners Hospitals simplified the process for our new patients; allowing patients' immediate scheduling for an appointment if their clinical needs meet the hospital's scope of service. To avoid any confusion to our patients or the community, temple staff are asked to no longer use the application form and remove any reference to a patient application process in temple materials or website.
