We must have a waiver completed for your business/organization to participate in the parade. **We cannot accept any participants the day of the parade, as the coordinators cannot confirm that a waiver has been signed.** Your business/organization is responsible for anyone that participates with you, unless they have completed a waiver themselves. The entrance deadline is **July 30th**. Late entries will be placed at the end of the parade, in front of the horses. You will receive a confirmation letter with your line-up information approximately two weeks before the parade.

Please ensure your business/organization name is visible to parade viewers and incorporate some type of Italian theme and/or green, white and red. All vehicles must adhere to state and local traffic regulations regarding weight and height.
